The Production Company agrees to return the property to its original condition and remove all equipment, props, and waste upon completion of filming. Any modifications must be restored unless otherwise agreed upon.

The Property Owner acknowledges that the Production Company owns the rights to all footage filmed on the premises and may use, edit, distribute, and exhibit the material without further permission or compensation.

- The Property Owner [DOES/DOES NOT] retain the right to rent the location to other productions during the agreed period.
- The Production Company agrees to abide by noise restrictions and other limitations as agreed upon.

In the event of cancellation, the following terms apply:

- If cancelled by the Production Company within [X] days of the shoot, a cancellation fee of £[AMOUNT] shall be paid.
- If cancelled by the Property Owner, any advance payments shall be refunded in full.
